According to art. 13 of EU Regulation no. 2016/679 (hereafter "GDPR 2016/679"), containing "provisions on the protection of natural persons with regard to the processing of personal data ", we wish to inform you that the personal data you have provided will be processed in compliance with the law mentioned above and the confidentiality obligations with which the Company MYT Systems Srl is required

1. Holder of the treatment

The Data Controller (The Company) is

2. Types of data collected

The Personal Data collected independently or through third parties are as follows.

 Personal Identification Data i.e .: name, surname, address, e-mail, telephone number, tax code, VAT number, etc.

However, you assume responsibility for the Personal Data of third parties that may be transmitted to the Data Controller, guaranteeing that you have the right to communicate them, thus freeing the Data Controller from liability to third parties.

3. Methods of data processing and storage

The Data Controller adopts the appropriate technological and organizational security measures aimed at guaranteeing the integrity, availability and confidentiality of Personal Data.

The processing is carried out using automated or manual tools. In addition to the Data Controller, in some cases, other subjects involved in the organization of work (collaborators) or external subjects (such as technical or administrative service providers) may have access to the Data.

4. Legal basis of the treatment

5. Place of treatment

The data are processed at the Data Controller's office or directly at Company's headquarter or any mobile location designated by the Data Subject.

6. Retention period

The data are processed and stored for the time required by the purposes for which they were collected, therefore:

- Personal Data collected for purposes related to the execution of a contract between the Data Controller and the Data Subject will be retained until the obligations deriving from this contract will expire.
- The Personal Data collected for purposes related to the legitimate interest of the Data Controller will be retained until this interest is satisfied.
- When the treatment is based on the consent of the Data Subject, the Data Controller can keep personal data longer until such consent is revoked by the Data Controller [opt-out].
- In addition, the Data Controller may be obliged to keep Personal Data for a longer period in compliance with a legal obligation or by order of an authority.

At the end of the retention period, Personal Data will be deleted. Therefore, at the end of this term, the right of access, cancellation, rectification and the right to data portability can no longer be exercised.

10. Special categories of personal data
